VILLAGE COUNCIL OF NORTH FAIRFIELD, OHIO ORDINANCE NO. 2020-O-02

AN ORDINANCE AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR TO A MAKE WRITTEN CONTRACT WITH THE LOWEST AND BEST BIDDER ERIE BLACKTOP FOR THE NEW STATE ROAD PROJECT AND DECLARING AN EMERGENCY

WHEREAS, in those villages that have established the position of village administrator, the village administrator shall make contracts. [Section 731.141 of the Ohio Revised Code; See also Section 133.02 of the Wakeman Codified Municipal Code]; and

WHEREAS, when an expenditure, other than the compensation of persons employed by the village, exceeds fifty thousand dollars, the expenditure shall first be authorized and directed by ordinance of the legislative authority of the village. [Section 731,141 of the Ohio Revised Code]; and

WHEREAS, when so authorized and directed, the village administrator shall make written contract with the lowest and best bidder; [Section 731.141 of the Ohio Revised Code]; and

WHEREAS, council previously authorized bids for the NEW STATE ROAD Project by Resolution No.: 2020-R-02; and

WHEREAS, HURON COUNTY ENGINEER, was designated by the village administrator to open and publicly read bids as permitted by ORC 731.141 (See Resolution No.: 2020-R-02); and

WHEREAS, in a letter to the village dated 3/16/20 the Huron County Engineer indicated that he has reviewed the bids and recommends the bid be awarded to Erie Blacktop.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NORTH FAIRFIELD, STATE OF OHIO: (RC 731.18)

SECTION 1. That Council finds and determines ERIE BLACKTOP, Sandusky, Ohio to be the lowest and best bidder in the amount of \$262,446.48.

SECTION 2. That Council hereby authorizes and directs the Village Administrator to make a written contract with the lowest and best bidder as determined and designated herein.

SECTION 3. That the contract shall be executed in the name of the village and signed on its behalf by the village administrator and the clerk. (See ORC 731,141)

<u>SECTION 4</u>. That the contract shall be in a form specified by the <u>HURON COUNTY</u> <u>ENGINEER</u>, <u>Responsible Lead Agency</u> and made a part hereof and expressly incorporated herein by reference.

SECTION 5. DISPENSE WITH THREE READINGS. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 6. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this Ordinance is hereby declared to be an emergency measure pursuant to RC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s): *County Engineer reports that project completion is scheduled approximately around 7/31/20*.

SECTION 7. PUBLIC MEETING. That it is found and determined that all formal action of this public body concerning or relating to the passage of this Resolution/Ordinance were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of section 121.22 of the Ohio Revised Code.

WHEREFORE, this legislation shall be in full force and effect from and after the earliest period allowed by law.
