AN ORDINANCE AMENDING ORDINANCE NO.: 2019-O-05 FIXING THE COMPENSATION OF THE FISCAL OFFICER AND OPERATOR OF RECORD AND DECLARING AN EMERGENCY

WHEREAS, Section 731.13 of the Ohio Revised Code provides that the legislative authority of a village shall fix the compensation of all officers, clerks and employees of the village. The legislative authority shall, in the case of elective officers, fix their compensation for the ensuing term of office at a meeting held not later than five days prior to the last day fixed by law for filing as a candidate for such office; and

WHEREAS; the compensation was previously fixed by Ordinance No. 2019-O-05; and

WHEREAS, Village Council wishes to adjust the compensation range of the Fiscal Officer; and

WHEREAS, Village Council further wishes to fix the compensation for the Operator of Record.

NOW THEREFORE, BE IT <u>ORDAINED</u> BY THE COUNCIL OF THE VILLAGE OF <u>NORTH</u> <u>FAIRFIELD</u>, STATE OF OHIO: (RC 731.18)

<u>SECTION 1</u>. That Section 2 of Village of North Fairfield Ordinance No.: <u>2019-O-05</u> is hereby amended as follows:

Fiscal Officer: \$800.00 to 2000.00 per month.

Paid from the Clerk Salary Account, General Fund, 50% and the Salaries-Administrator's Office Account, Water Fund 50%.

Operator of Record: Up to 1,200.00 per month.

Paid from Salaries-Administrator's Office Account, Water Fund.

<u>SECTION 3</u>. <u>REPEAL</u>. Any part of Ordinance <u>2019-O-05</u> inconsistent herewith is hereby rescinded and repealed.

SECTION 4. DISPENSE WITH THREE READINGS. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.
