#### SUPPLEMENTAL APPROPRIATION MEASURE RC 5705.38

AN ORDINANCE SUPPLEMENTING AND AMENDING THE **2020** ANNUAL PERMANENT APPROPRIATION ORDINANCE

(Page 6-12]; and

WHEREAS, the Fiscal Officer advises that it is necessary to amend the Annual Appropriation Ordinance to appropriate additional unappropriated monies; and

WHEREAS, the Fiscal Officer specifically reports that; "This was deposited in our account by mistake. It is to go to the fire department."

WHEREAS, the Fiscal Officer reports that the amendment(s) and supplement(s) herein are measures providing for appropriations for the current expenses of the village and should go into immediate effect pursuant to section 731.30 of the Ohio Revised Code.
