VILLAGE COUNCIL OF NORTH FAIRFIELD, OHIO ORDINANCE NO: 2020-O-05

AN ORDINANCE FIXING THE COMPENSATION OF ALL OFFICERS,
CLERKS AND EMPLOYEES OF THE VILLAGE AND REPEALING ALL
PREVIOUS COMPENSATION ORDINANCES AND AMENDMENTS

RC 731.13

WHEREAS, Section 731.13 of the Ohio Revised Code provides that the legislative authority of a village shall fix the compensation of all officers, clerks and employees of the village. The legislative authority shall, in the case of elective officers, fix their compensation for the ensuing term of office at a meeting held not later than five days prior to the last day fixed by law for filing as a candidate for such office; and

WHEREAS, Village Council wishes to update and consolidate all previous compensation ordinances and amendments into one current compensation ordinance for all officers, clerks and employees of the village: and

WHEREAS, Village Council does not currently wish to address the compensation of elected officials.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NORTH FAIRFIELD, STATE OF OHIO: (RC 731.18)

SECTION 1. That pursuant to Section 731.13 of the Ohio Revised Code, the legislative authority of the village hereby fixes the compensation off all officers, clerks and employees of the village as follows:

FISCAL OFFICER \$800.00 to 2,000.00 PER MONTH
Compensation shall be paid from the following:


