#### SUPPLEMENTAL APPROPRIATION MEASURE RC 5705.38

AN ORDINANCE SUPPLEMENTING AND AMENDING THE **2021** ANNUAL PERMANENT APPROPRIATION ORDINANCE

WHEREAS, Village Council previously passed Ordinance No.: 2021-O-02 titled Annual Appropriation Ordinance setting the annual appropriations for the year and providing for the current expenses and other expenditures of the village; and

WHEREAS, Section 5705.38(A) of the Ohio Revised Code provides that during the year the taxing authority of the subdivision may pass any supplemental appropriation measures as it finds necessary; and

WHEREAS, Section 5705.40 of the Ohio Revised Code provides that any appropriation ordinance or measure may be amended or supplemented; and

WHEREAS, an ordinance by village council is necessary when the appropriation amendment will result in a reallocation of the line item amounts approved in the village's permanent appropriation ordinance [See Village Officer's Handbook, March 2019, Chapter Six: Accounting Procedures, Section IX Amending Appropriations. (Page 6-12]; and

WHEREAS, the Fiscal Officer reports that the amendment(s) and supplement(s) herein are measures providing for appropriations for the current expenses of the village and should go into immediate effect pursuant to section 731.30 of the Ohio Revised Code.

WHEREAS, the Fiscal Officer specifically reports that the village is in receipt of <u>unanticipated funds</u>.

NOW THEREFORE, BE IT <u>ORDAINED</u> BY THE COUNCIL OF THE VILLAGE OF NORTH FAIRFIELD, STATE OF OHIO:  $(RC\ 731.18)$
