## SUPPLEMENTAL APPROPRIATION MEASURE RC 5705.38

(Page 6-12]; and

WHEREAS, the Fiscal Officer reports that the amendment(s) and supplement(s) herein are measures providing for appropriations for the current expenses of the village and should go into immediate effect pursuant to section 731.30 of the Ohio Revised Code; and

WHEREAS, the Fiscal Officer specifically reports that: The Permanent Annual Appropriation Measure Ordinance requires supplementing in order to account for <u>Utilities (Consumer Gas)</u>.
