A RESOLUTION ACCEPTING THE DONATION OF TWO (2) PICNIC TABLES DONATED BY THE NORTH FAIRFIELD COMMUNITY IMPROVEMENT GROUP TO BE INSTALLED AT SOUTH MAIN STREET PARK

WHEREAS, Section 9.20 of the Ohio Revised Code provides that a municipal corporation or the legislative authority, a board, or other officers of a municipal corporation; may receive by gift, devise, or bequest moneys, lands, or other properties, for their benefit or the benefit of any of those under their charge and may hold and apply the moneys, lands, or properties according to the terms of the gift, devise, or bequest; and

WHEREAS, Kali Beck of the North Fairfield Community Improvement Group *(Note: Not yet incorporated as a Community Improvement Corporation (C.I.C.) under Chapter 1724 of the Ohio Revised Code)* reports (See Council meeting minutes of [date(s)]) that the Group has acquired two (2) picnic tables from CSX Railroad; and

WHEREAS, Kali Beck of the North Fairfield Community Improvement Group further reports (SEE Council meeting minutes of [date(s)]) that the Group desires to donate the picnic tables to the Village of North Fairfield to be placed in the South Main Street Park; and

WHEREAS, the specific picnic tables (*SuperSaver™ Commercial Rectangular Picnic Tables 1WG5687, SKU TPT-80*) are currently valued on picnictables.com at \$998.95 each; and

WHEREAS, the Village of North Fairfield does not currently have a GIFTS / DONATION POLICY, so the matter is now before Village Council for consideration.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NORTH FAIRFIELD, STATE OF OHIO: (RC 731.18)

SECTION 1. That the Village of North Fairfield hereby accepts the dedication / donation of two (2) picnic tables from the North Fairfield Community Improvement Group.

SECTION 2. That the two (2) donated picnic tables shall be placed, installed, and remain at South Main Street Park in the Village of North Fairfield, Ohio.

SECTION 3. That the Village shall maintain the two (2) picnic tables at South Main Street Park and shall provide any and all necessary maintenance and repair until such time as the tables are no longer fit or safe for their intended public purpose.

SECTION 4. PUBLIC MEETING. That it is found and determined that all formal action of this public body concerning or relating to the passage of this Resolution/Ordinance were adopted in a public meeting open to the public at all times, and that all deliberations of the public body and any of its committees that resulted in such formal action, were in public meetings open to the public, in compliance with all legal requirements including all lawful ordinances and any applicable provisions of section 121.22 of the Ohio Revised Code.

WHEREFORE, this legislation shall be in full force and effect from and after the earliest period allowed by law.

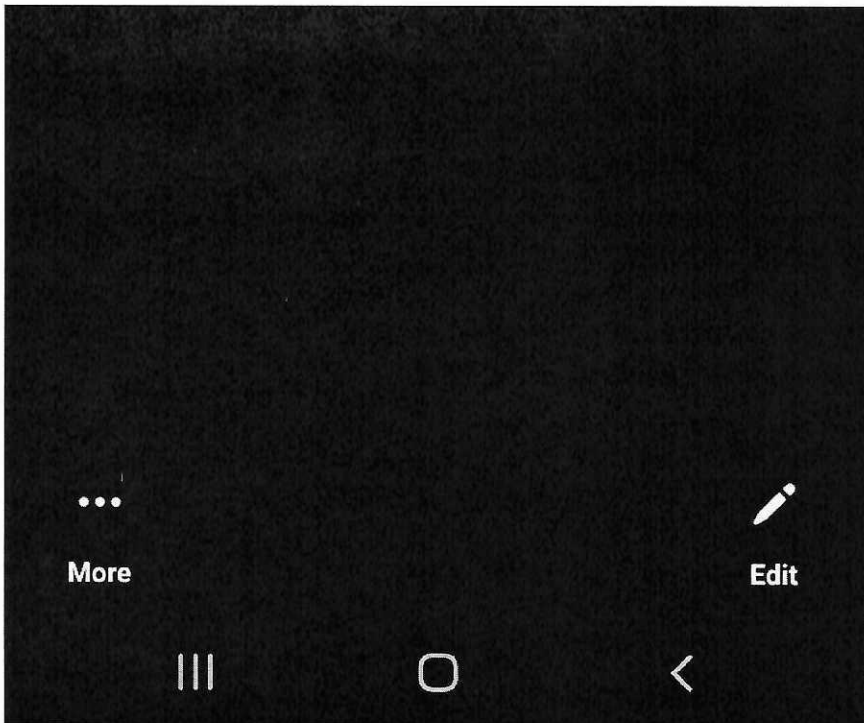
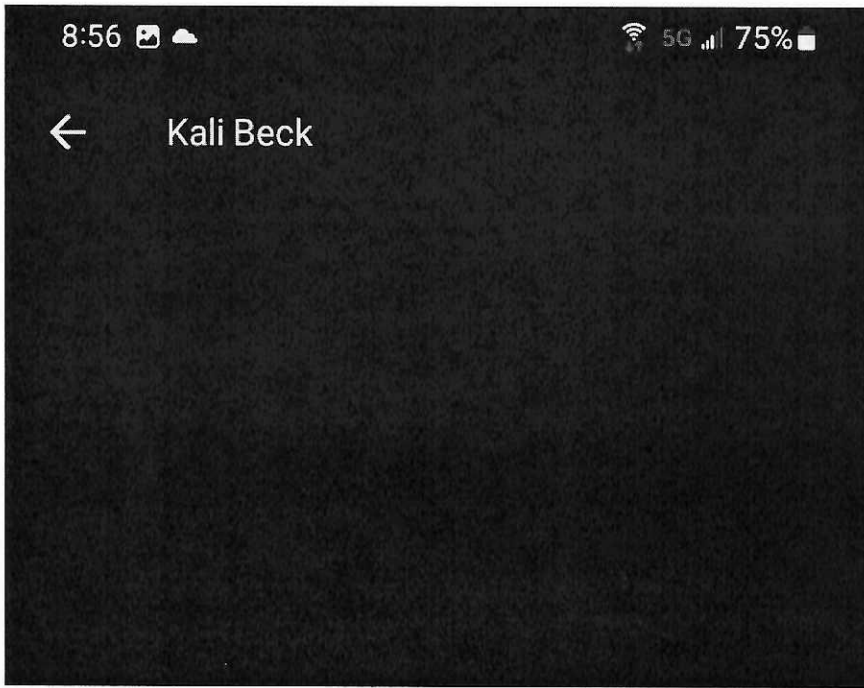
