MEETINGS OF THE LEGISLATIVE AUTHORITY TIME AND PLACE

AN ORDINANCE PRESCRIBING THE TIME AND PLACE OF THE MEETINGS OF VILLAGE COUNCIL AND DECLARING AN EMERGENCY

WHEREAS, Section 731.46 of the Ohio Revised Code provides that the meetings may be held at such time and place as is prescribed by ordinance and shall, at all times, be open to the public [See also North Fairfield Council Rules, Rule 14(B)]; and

WHEREAS, the time and place for council meetings was previously prescribed in Ord 2002-O-04 within Rules of Council, Section I Meetings, A. Regular Meetings and then again in Ord 2021-O-04.

NOW THEREFORE, BE IT <u>ORDAINED</u> BY THE COUNCIL OF THE VILLAGE OF <u>NORTH</u> <u>FAIRFIELD</u>, STATE OF OHIO: (RC 731.18)

<u>SECTION 1</u>: That Village Council hereby prescribes that REGULAR SESSIONS of council meetings shall be held at the following time and place:

TIME: First Monday of each month promptly at 7:00 o'clock PM.

PLACE: Village Hall, located at 3 East Main Street, North Fairfield, Ohio 44855.

SECTION 2: That Councilman Adam Rouse may notify the County Board of Elections.

SECTION 3. That the mayor, or any three members of the legislative authority may call special meetings upon at least twelve hours' notice to each member, served personally or left at his usual place of residence. (See RC 731.46)

SECTION 4. <u>DISPENSE WITH THREE READINGS</u>. [R.C. 731.17(A)(2)] That the legislative authority, upon a vote of at least three-fourths of its members, hereby dispenses with the rule requiring each ordinance or resolution shall be read on three different days.

SECTION 5. DECLARATION OF EMERGENCY FOR IMMEDIATE EFFECT. That by two-thirds vote of all the members elected to the legislative authority, this Ordinance/Resolution is hereby declared to be an emergency measure pursuant to RC 731.30, being necessary for the immediate preservation of the public peace, health, or safety of the municipal corporation and shall go into immediate effect for the following reason(s): *To begin the new regular meeting schedule in 2023*.
