#### SUPPLEMENTAL APPROPRIATION MEASURE RC 5705.38

AN ORDINANCE SUPPLEMENTING AND AMENDING THE **2023** PERMANENT APPROPRIATION MEASURE ORDINANCE

WHEREAS, Section 5705.40 of the Ohio Revised Code provides that any appropriation ordinance or measure may be amended or supplemented; and

WHEREAS, an ordinance by village council is necessary when the appropriation amendment will result in a reallocation of the line item amounts approved in the village's permanent appropriation ordinance [See Village Officer's Handbook, March 2019, Chapter Six: Accounting Procedures, Section IX Amending Appropriations. (Page 6-12]; and

WHEREAS, the Fiscal Officer reports that the amendment(s) and supplement(s) herein are measures providing for appropriations for the current expenses of the village and should go into immediate effect pursuant to section 731.30 of the Ohio Revised Code; and

WHEREAS, the Fiscal Officer specifically reports that: The village received unanticipated revenue from an anonymous donor.

NOW THEREFORE, BE IT <u>ORDAINED</u> BY THE COUNCIL OF THE VILLAGE OF NORTH FAIRFIELD, STATE OF OHIO: (RC 731.18)

<u>SECTION 1</u>. That Council finds it necessary to supplement and amend the Permanent Appropriation Measure Ordinance No.: 20<u>23</u>-O-<u>02</u>as follows:
