# POSTING LOCATIONS R.C. 731.25

AN ORDINANCE AMENDING AND ESTABLISHING POSTING LOCATIONS FOR SUMMARIES OF LEGISLATION AND OTHER MUNICIPAL NOTICES AS REQUIRED BY R.C. 731.25.

WHEREAS, Section 731.21 of the Ohio Revised Code requires that a succinct summary of each municipal ordinance or resolution and all statements, orders, proclamations, notices, and reports required by law or ordinance to be published shall be published in a newspaper of general circulation in the municipal corporation; and

WHEREAS, Section 731.25 of the Ohio Revised Code provides that in municipal corporations in which no newspaper is generally circulated, publication of summaries of ordinances and resolutions, and publication of all statements, orders, proclamations, notices, and reports, required by law or ordinance to be published, shall be accomplished by posting copies in not less than five of the most public places in the municipal corporation, as determined by the legislative authority, for a period of not less than fifteen days prior to the effective date thereof; and.

WHEREAS, Section 731.25 of the Ohio Revised Code further provides that where such publication is by posting, the clerk shall make a certificate as to such posting, and as to the times when and the places where such posting is done, in the manner provided in section 731.24 of the Revised Code, and such certificate shall be prima-facie evidence that the copies were posted as required; and

WHEREAS, Section 731.24 of the Ohio Revised Code requires that immediately after the expiration of the period of publication of summaries of ordinances required by section 731.22 of the Revised Code, the clerk of the legislative authority of a municipal corporation shall enter on the record of ordinances, in a blank to be left for such purpose under the recorded ordinance, a certificate stating in which newspaper and on what dates such publication was made, and shall sign the clerk's name thereto officially. Such certificate shall be prima-facie evidence that legal publication of the summary of the ordinance was made.

WHEREAS, posting locations were most recently established and updated by Ord 2019-O-12;

WHEREAS, the council now wishes to update and amend the current posting locations.
