SOLID WASTE MANAGEMENT PLAN

A RESOLUTION APPROVING THE DRAFT SOLID WASTE MANAGEMENT PLAN FOR THE HURON COUNTY SOLID WASTE MANAGEMENT DISTRICT AND DECLARING AN EMERGENCY

WHEREAS, the Village of **NORTH FAIRFIELD** is located within the jurisdiction of the Huron County Solid Waste Management District (hereinafter "District"); and

WHEREAS, the Policy Committee for the District adopted a draft Solid Waste Management Plan on August 2nd, for the fifteen-year period beginning in 2024 and ending in 2038; and

WHEREAS, the draft Solid Waste Management Plan for the District was submitted to council for its review in accordance with the requirements of Chapters 343 and 3734 of the Ohio Revised Code; and

WHEREAS, pursuant to RC 3734.55(B), within ninety days after receiving a copy of the draft plan adopted by the committee, the legislative authority shall approve or disapprove the draft plan, by ordinance or resolution, and deliver a copy of the ordinance or resolution to the committee; and

WHEREAS, the village previously approved a Solid Waste Management Plan for the Huron County Solid Waste Management District in Resolution No.: <u>2003-R-07</u>. (Note: The Fiscal Officer reports that the Village may not have participated in draft plan approval in 2017).

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NORTH FAIRFIELD, STATE OF OHIO: $(RC\ 731.18)$

<u>SECTION 1</u>. That the draft Solid Waste Management Plan for the Huron County Solid Waste Management District is hereby ratified and approved.
