- Judy Lykins The mission of the Huron County Land Reutilization Corporation is the preservation, restoration, or disposal of abandoned or foreclosed properties. To strategically acquire properties, return them to productive us, reduce blight, increase property values, support community goals, and improve the quality of life for Huron County residents. Tuesday or Wednesday there will be someone around to take samples of the building to send to the lab and find out what kind of yuck they will be dealing with. The property will be abated. We are getting all the cost around to go into the grant application. Once this is torn down then the property will be turned back over to the land owner.
- > Council discussed activities the Improvement Group has planned.

 - 2. August 2-3, 2024 is the Street Fair
 - 3. November 28, 2024 is the Turkey Trott
 - 4. The Gaga Pit is worth \$1,500.00. It is 6 panels at 8' long.
- > Council discussed the heavy trucks in the village. They would like to get prices on "NO thru Trucks" signs. The village administrator thinks we should put a weight limit. The question is what about Flashes, would they be overweight? It was stated that they would not be a thru trucks.
- We need to get quotes to have the trees removed and or cleaned up.
